At the end of the Initial Membership Period, the membership will automatically renew on a month-to-month basis until either party notifies the other in writing with no less than a thirty day notice.

- Notice of Consumer Rights.** (1) Royal Fitness and Nutrition L.L.C. is registered with the Maryland Consumer Protection Division, registration no. E2600. (2) You have the right to cancel this agreement within three business days after receipt of a copy of this agreement. Cancellation must be in writing, and delivered in person or by certified/registered mail. If you cancel, you are entitled to a full refund of all monies paid. (3) In the event that Client becomes disabled and unable to further utilize Royal Fitness and Nutrition L.L.C., which must be verified by a physician in writing, Client is entitled to cancel the membership and receive a prorated refund of any prepaid Monthly Fees. If Client becomes disabled for at least three months during a membership, and such disability is confirmed by a physician, Client may have the membership extended for a period equal to the duration of disability. All such cancellations and verifications must be submitted in writing to Royal Fitness and Nutrition, 4550 Montgomery Avenue, Suite 200N, Bethesda, Maryland 20814. (4) If Royal Fitness and Nutrition L.L.C. is closed for Thirty days or more through no fault of Client, then Client shall be entitled to either an extension of membership equal to the period which Royal Fitness and Nutrition L.L.C. is closed or prorated refund of monthly fees.

OR ANY OTHER LOCATION. 2) No agreements are recognized other than those contained herein. This contract may not be altered or modified by any employee or agent of Royal Fitness and Nutrition L.L.C. either orally or in writing. 3) Fee Schedule. Royal Fitness and Nutrition L.L.C. reserves the right to increase the monthly fee at the end of the first year, and each year thereafter, at the rate of ten percent (10%) or the percentage increase of the consumer price index for the previous twelve (12) months, whichever is greater. Any increase in excess of this must be negotiated with the client.
